R# 1 / 2026 APPROVE DECEMBER 30, 2025 MINUTES

Motion by Mr. Maxson seconded by Mr. Kaffenbarger to approve the December 30, 2025 meeting minutes. Motion passed.

R# 2/ 2026 PAY BILLS FOR JANUARY 2026

Motion by Mr. Maxson, seconded by Mr. Kaffenbarger to pay bills for January 2026. Motion passed.

Nicole submitted a written PTO policy, Trustees looked over and discussed, Scott will send to the county prosecutor for review.

Scott advised 14 runs so for this year, stair chair pair auction on govdeals ends tomorrow, the bids are up to \$ 1800, we are the top bidder. He submitted a survey to the BWC regarding the rescue tool purchased with the BWC Grant. All Medicount runs are submitted thru January 5, 2026, he has an interview scheduled for a potential new hire on Thursday.

R# 3 / 2026 APPROVE PAYMENT TO STRYKER FOR BATTERIES FOR COT AND AED

Motion by Mr. Maxson, seconded by Mr. Kaffenbarger to approve payment to Stryker for batteries in the amount of \$ 1,781.22 for the cot in Unit 253 and AED. Motion passed.

Jerry provided the Trustees with a copy of the Good Faith Agreement, he would like to amend it from 24 hours a month to 24 hours a week for 24 months. Jerry asked Cheryl to provide him with the township valuation to fill out the annual VFDF (Volunteer Firefighters Dependency Fund) paperwork.

R# 4 / 2026 AMEND GOOD FAITH AGREEMENT FOR EMTS

Cheryl advised when inputting temporary appropriations, she left out appropriating any amount for Fire fund 21111-220-382 Liability insurance, a supplemental will be needed to add it.

R# 5 / 2026 INCREASE FIRE 2111-220-382 LIABILITY INSURANCE

Motion by Mr. Maxson, seconded by Mr. Kaffenbarger increase the Fire fund 2111-220-382 Liability Insurance \$ 22,000.00 and file a supplemental appropriation.

R# 6 / 2026 IRS MILEAGE REIMBURSEMENT 72.5 CENTS PER MIE

Motion by Mr. Maxson, seconded by Mr. Kaffenbarger to approve the 2026 IRS mileage reimbursement of 72.5 cents per mile, up 2.5 cents in 2025. Motion passed.

Cheryl received the inventory, vehicle milage and hours and FD roster and will submit to the County Engineer.

Mr. Kaffenbarger discussed the email from the County Engineer regarding 2026 road bids, tabled this until next meeting.
