

Pike Township Aggregation Bulletin

(This is NOT an opt out notice. No action required.)

Residents and Businesses of Pike Township,

Electric Aggregation Program:

The Pike Township electric aggregation program has ended with Energy Harbor with the April 2023 meter read dates. All residents will return to the utility for one month. The rate with Ohio Edison for May will be a **rate of \$0.059000 per kwh**. The new electric aggregation program with Dynegy will start with June meter read date. If you received a letter from Dynegy and did not opt out of the program, you will be included in the new aggregate program.

Pike Township is providing you with the opportunity to join with other residents to save money on the electric you use. Savings are possible through a concept called government aggregation, where the Township officials bring together citizens to gain group-buying power for the purchase of electric from a retail supplier certified by the Public Utilities Commission of Ohio. Pike Township voters approved this program in November 2014.

Under this arrangement, Dynegy has been selected as your Township's preferred electricity provider.

FirstEnergy Ohio has filed an updated rate starting June 1st, 2023. The rate will be \$0.121480 per kwh.

Through your Township Electric Aggregation Program, eligible residents and businesses will be receiving a **rate of \$0.069000 per kwh**. This program will begin in June 2023 and will be available through June 2025 meter reading. There is no cost for the enrollment, and you **will not** be charged a switching fee. *There is no early termination fee to leave the program at any point in the future.*

Budget billing of the entire bill is available to anyone who prefers budget certainty. As with the utility you will still be required to request the service directly from the supplier. Dynegy can be reached at the toll-free number listed below.

If you already have a supplier, under contract or not, and would like to inquire about joining the aggregation please follow the simple steps below.

1. Call your existing supplier first. Ask them what the early termination fee is to leave them as a supplier.
 - a. If there is zero early termination fee, ask the supplier to place your account back with the utility.
 - b. If there is an early termination fee, you must decide if it's worth leaving the supplier early to join the aggregation. If you still want to proceed with joining the Aggregation, then direct the supplier to place your account back with the utility.

2. Call the aggregation supplier, listed on the front of this letter, and tell them you would like to join the community aggregation. Be specific about which community.
